RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE DEED OF DONATION TO BE EXECUTED BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO FOR PROVIDING THE CITY WITH TWO (2) UNITS GPS EQUIPMENT WORTH SEVENTY NINE THOUSAND SIX HUNDRED PESOS (P79,600.00).

WHEREAS, letter dated August 14, 2018 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in the Deed of Donation to be executed by and between the Province of Negros Occidental and the City Government of Bago for providing the City with Two (2) units GPS Equipment worth Seventy Nine Thousand Six Hundred Pesos (P79,600.00);
