RESOLUTION APPROVING AND FAVORABLY ENDORSING TO THE DPWH 4TH ENGINEERING OFFICE RESOLUTION NO. 2018-003 OF THE BARANGAY COUNCIL OF BARANGAY SAMPINIT, BAGO CITY, ENTITLED: "RESOLUTION REQUESTING THE DPWH 4TH ENGINEERING OFFICE THROUGH THE SANGGUNIANG PANLUNGSOD, BAGO CITY, TO INCLUDE FOR FUNDING THROUGH AVAILABLE FUNDS AND PROGRAMS OF THE DPWH THE UPGRADING/IMPROVEMENT OF DRAINAGE SYSTEM AT THE FOLLOWING LOCATIONS, BARANGAY SAMPINIT, THIS CITY, 1. CONSTRUCTION OF CLOSED DRAINAGE ALONG ARANETA STREET FROM SAMPINIT CREEK TO SIBUD CREEK; 2. STRAIGHTENING OF SIBUD CREEK INCLUDING ACQUISITION OF RIGHT-OF-WAY; 3. CONSTRUCTION OF MAIN DRAINAGE OUTFALL WITH CONCRETING ACCESS ROAD FROM BACOLOD-SOUTH ROAD TO GUIMARAS STRAIT AND PUROK MAHIDAITON, BARANGAY SAMPINIT".

WHEREAS, Indorsement letter dated August 22, 2018 from the Honorable City Mayor, respectfully referred to this Honorable body, the request for approval of Resolution No. 2018-003 of the Barangay Council of Barangay Sampinit, Bago City;

WHEREAS, after a thorough deliberation on the matter, it was the consensus of this August Body to approve said Resolution;

NOW, THEREFORE, upon motion of SP Member Jorge Agustin A. Araneta, unanimously seconded by SP Members present, the Sanggunian Panlungsod

RESOLVES, as it is hereby resolved, to approve and favorably endorse to the DPWH 4th Engineering Office Resolution No. 2018-003 of the Barangay Council of Barangay Sampinit, Bago City, entitled: "Resolution requesting the DPWH 4th Engineering Office through the Sangguniang Panlungsod, Bago City, to include for funding through available funds and programs of the DPWH the Upgrading/Improvement of drainage system at the following locations, Barangay Sampinit, this City, 1. Construction of Closed Drainage along Araneta Street from Sampinit Creek to Sibud Creek; 2. Straightening of Sibud Creek including acquisition of right-of-way; 3. Construction of main drainage outfall with concreting access road from Bacolod-South Road to Guimaras Strait and Purok Mahidaiton, Barangay Sampinit".
