RESOLUTION REQUESTING NATIONAL GOVERNMENT OFFICES ASSIGNED IN THE CITY OF BAGO TO REQUIRE THEIR RESPECTIVE PERSONNEL PROCESSING THEIR CLEARANCE PRIOR TO TRANSFER, RETIREMENT OR RESIGNATION TO SECURE NECESSARY CLEARANCE FROM PROPERTY ACCOUNTABILITIES WITH THE LOCAL GOVERNMENT, MAKING THE SAME A REQUIREMENT BY THEIR OFFICE PRIOR TO APPROVING SAID TRANSFER, RESIGNATION OR RETIREMENT.
