RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND CENTRAL NEGROS ELECTRIC COOPERATIVE, INCORPORATED FOR THE CONSTRUCTION OF THE EXTENSION OF 1-SPAN 1-PHASE PRIMARY LINE, INSTALLATION OF 1-50 KVA DISTRIBUTION TRANSFORMER, SECONDARY METERING AND STRINGING OF SERVICE WIRES AT THE BAGO CITY TRAINING CENTER, TLDC COMPOUND, BAGO CITY.

WHEREAS, in his letter dated January 12, 2010, the Honorable City Mayor is requesting for a resolution to be passed by this August Body, authorizing him to sign for and in behalf of the City Government of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Central Negros Electric Cooperative, Incorporated for the construction of the extension of 1-span 1-phase primary line, installation of 1-50 kva distribution transformer, secondary metering and stringing of service wires at the Bago City Training Center, TLDC Compound, Bago City;
