RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGION VI, RELATIVE TO THE IMPLEMENTATION OF THE NPS-ENRM PROJECT WITH PROGRAM SUPPORT FROM THE WORLD BANK AND GLOBAL ENVIRONMENT FACILITY.
