RESOLUTION NO. 10-056

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF AGRARIAN REFORM FOR A COLLABORATION IN THE IMPLEMENTATION OF AGRARIAN REFORM COMMUNITIES PROJECT 2 (ARCP 2), PURPOSELY TO ADDRESS RURAL POVERTY OF SELECTED AGRARIAN REFORM COMMUNITIES AND TO PROVIDE EFFECTIVE AND EFFICIENT DELIVERY OF ESSENTIAL SUPPORT SERVICES TO THE ARCS WITHIN THE LGU AND OTHER RELATED ACTIVITIES THAT WOULD PROMOTE COMMUNITY DRIVEN DEVELOPMENT, IMPROVE LEVELS OF PRODUCTIVITY, INCREASE HOUSEHOLD INCOME AND ENHANCE THE QUALITY OF LIFE IN THE ARCS.

WHEREAS, in his letter dated January 19, 2010 from the Hon. City Mayor, addressed to the Hon. Members, Sangguniang Panlungsod, this City, re: Requesting that a resolution be passed authorizing the Hon. City Mayor to sign for and in behalf of the City Government of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Department of Agrarian Reform for a collaboration in the implementation of Agrarian Reform Communities Project 2 (ARCP 2), purposely to address rural poverty of selected Agrarian Reform Communities and to provide effective and efficient delivery of essential support services to the ARCs within the LGU and other related activities that would promote community driven development, improve levels of productivity, increase household income and enhance the quality of life in the ARCs;
