RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE BAGO CITY COLLEGE, BEING THE CHAIRMAN OF THE BOARD OF TRUSTEES AND PHILIPPINE AIR FORCE, AIR FORCE RESERVE COMMAND, 5TH AIR RESERVE CENTER TO OFFER AND CONDUCT AIR FORCE RESERVE OFFICER TRAINING COURSE (AFROTC) PROGRAM TO THE BAGO CITY COLLEGE STUDENTS.

WHEREAS, in his letter dated January 19, 2010 from the Hon. City Mayor, addressed to the Hon. Members, Sangguniang Panlungsod, this City, re: Requesting that a resolution be passed authorizing the Hon.
