RESOLUTION ENDORSING THE PROJECT AND AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL FOR A FINANCIAL ASSISTANCE TO THE CITY GOVERNMENT FOR THE BACKFILLING OF BANTAYAN PARK (PHASE III), THIS CITY.

WHEREAS, in his letter dated January 27, 2010 from the Hon. City Mayor, addressed to the Hon. Members, Sangguniang Panlungsod, this City, re: Requesting that a resolution be passed endorsing the project and authorizing the Hon.
