RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE OFFICE OF THE CONGRESSMAN, FOURTH CONGRESSIONAL DISTRICT OF NEGROS OCCIDENTAL AND BAGO CITY COLLEGE, REPRESENTED BY THE HONORABLE CITY MAYOR AS THE CHAIRMAN OF THE BOARD OF TRUSTEES FOR A SCHOLARSHIP PROGRAM TO POOR BUT DESERVING COLLEGE STUDENTS IN THE 4TH DISTRICT OF NEGROS OCCIDENTAL AT BAGO CITY COLLEGE.

WHEREAS, in his letter dated February 23, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, authorizing him to sign for and in behalf of the City Government in a Memorandum of Agreement to be executed by and between the Office of the Congressman, Fourth Congressional District of Negros Occidental and Bago City College, represented by the Honorable City Mayor as the Chairman of the Board of Trustees for a Scholarship Program to poor but deserving college students in the 4th District of Negros Occidental at Bago City College;

WHEREAS, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;
