RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT IN A PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCE OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO FOR AN EMERGENCY ASSISTANCE FROM THE PROVINCIAL GOVERNMENT TO THE DISADVANTAGED/NEEDY POPULACE OF THE CITY.

WHEREAS, in his letter dated March 1, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, authorizing him to sign for and in behalf of the City Government in a Project Proposal and Memorandum of Agreement to be executed by and between the Province of Negros Occidental and the City Government of Bago for an emergency assistance from the Provincial Government to the disadvantaged/needy populace of the City;
