RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE THROUGH THE DEPARTMENT OF AGRICULTURE-REGIONAL FIELD UNIT VI AND THE CITY OF BAGO IN THE IMPLEMENTATION OF BREEDER TANDEM RESTOCKING (BTR) PROGRAM THROUGH PROVIDING FARMERS EASY ACCESS TO SWINE BREEDERS OF SUPERIOR GENETIC MAKEUP THROUGH ARTIFICIAL INSEMINATION SERVICES.
