RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT IN THE PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY OF BAGO AND PROVINCE OF NEGROS OCCIDENTAL FOR A FINANCIAL ASSISTANCE FROM THE PROVINCIAL GOVERNMENT FOR THE CONSTRUCTION OF ONE (1) UNIT DAY CARE CENTER AT BARANGAY MA-AO, THIS CITY.

WHEREAS, in his letter dated March 23, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, authorizing him to sign for and in behalf of the City Government in the Project Proposal and Memorandum of Agreement to be executed by and between the City of Bago and Province of Negros Occidental for a financial assistance from the Provincial Government for the Construction of One (1) Unit Day Care Center at Barangay Ma-ao, this City;
