WHEREAS, in his letter dated April 30, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this august body endorsing the construction of a Sanitary Landfill as component of our Eco-Center Project at Sitio Pandan, Barangay Ma-ao, this City, in compliance with the mandate of Republic Act 2003, otherwise known as the Ecological Solid Waste Management Act of 2000;
