**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS AND THE CITY OF BAGO FOR THE IMPLEMENTATION OF THE SPECIAL LOCAL ROAD FUND (SLRF) UNDER REPUBLIC ACT NO. 8794, OR THE MOTOR VEHICLE USER'S CHARGE (MVUC) LAW.**

**WHEREAS**, in his letter dated May 4, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, authorizing him to sign for and in behalf of the City Government of Bago in a Memorandum of Agreement to be executed by and between the Department of Public Works and Highways and the City of Bago for the Implementation of the Special Local Road Fund (SLRF) under Republic Act No. 8794, or the Motor Vehicle User's Charge (MVUC) Law;
