FARMS CORPORATION IN THE DONATION OF VARIOUS ROAD LOTS SITUATED AT VILLA CRISTETA SUBDIVISION PHASE 2 AT BARANGAY MA-AO, BAGO CITY.

WHEREAS, in his letter dated May 18, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body authorizing him to sign for and in behalf of the City Government of Bago in a Deed of Donation to be executed by and between the City Government of Bago and A.D.
