RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DR. LEONILO DEL CARMEN IN THE PRACTICE OF HIS PROFESSION FOR A FEE AS GENERAL SURGEON AT BAGO CITY HOSPITAL DURING HIS OFF-DUTY AND ALLOWING HIM TO USE THE HOSPITAL FACILITIES SUBJECT TO CERTAIN TERMS AND CONDITIONS.
