RESOLUTION REQUESTING THE HONORABLE CITY MAYOR TO CREATE THE BAGO CITY ADVISORY COMMITTEE TO MONITOR THE IMPLEMENTATION OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4 P's) IN THIS CITY.

WHEREAS, the Pantawid Pamilyang Pilipino Program is a laudable national program aimed at poverty reduction among indigent families with at least three (3) 0-14 children whose nutrition, health and education must be urgently addressed by a Conditional Cash Transfer (CCT);

WHEREAS, about 500 poor families in Bago City have been identified to qualify as beneficiaries of the 4 P's;

WHEREAS, the Local Government Unit is mandated to create a City Advisory Committee to monitor the implementation of this program;

NOW, THEREFORE, upon motion of SP Member Bernadette M. Somcio, unanimously seconded by SP Members present, the Sanggunian

RESOLVES, as it is hereby resolved to request the Honorable City Mayor to create the Bago City Advisory Committee to monitor the implementation of the Pantawid Pamilyang Pilipino Program (4 P's) in this city.
