RESOLUTION NO. 10-349

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND PHILIPPINE CROP SCIENCE INSURANCE CORPORATION (PCIC) FOR A CROP INSURANCE PROGRAM TO COVER INITIALLY TO PALAY, CORN, LIVESTOCK, OTHER HIGH-VALUE CROPS AND AGRICULTURAL ASSETS OF BOTH BORROWING AND SELF-FINANCED FARMERS QUALIFIED UNDER THE RULES AND REGULATIONS OF PCIC.

WHEREAS, in his letter dated July 27, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Philippine Crop Science Insurance Corporation (PCIC) for a crop insurance program to cover initially to Palay, Corn, Livestock, other High-Value Crops and Agricultural Assets of both borrowing and self-financed farmers qualified under the Rules and Regulations of PCIC;

WHEREAS, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;
