RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), BACOLOD BRANCH, RELATIVE TO THE LATTER'S INTENT TO EXTEND SALARY LOAN TO THE EMPLOYEES OF THE CITY GOVERNMENT OF BAGO.

WHEREAS, in his letter dated August 3, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, authorizing him to sign for and in behalf of the City Government in the Memorandum of Agreement to be executed by and between the City Government of Bago and the Development Bank of the Philippines (DBP), Bacolod Branch, relative to the latter's intent to extend salary loan to the employees of the City Government of Bago;
