WALTER VILLANUEVA AND THE NEW BLOOD CHANNEL REPRESENTED BY LIZA SANTILLAN FOR PROVIDING SERVICES FOR LABORATORY TESTS/EXAMINATION AT THE BAGO CITY HOSPITAL LABORATORY AS A REQUIREMENT FOR THE RENEWAL OF THE LICENSE OF BAGO CITY HOSPITAL WITH THE DEPARTMENT OF HEALTH.
