RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DR. JESSIELYN A. DOROMAL, A PRIVATE PRACTICING PHYSICIAN WITH SPECIALIZATION IN THE FIELD OF GENERAL MEDICINE, PEDIATRICS AND SURGERY WHO WOULD LIKE TO USE THE FACILITIES OF THE BAGO CITY HOSPITAL FOR HER PATIENTS IN THE LOCAL COMMUNITY FOR A FEE.
