- 1. CONSTRUCTION OF FOOTWALK AT PUROK PAG-UNLAD AND CALLE ONSE & REPAIR OF DRAINAGE AT PUROK RIVERSIDE, BRGY. MA-AO, BAGO CITY**
- 2. TO BE USED IN CPDO**
- 3. FOR DEVELOPMENT OF MA. MORENA RELOCATION PROJECT (LGU COUNTERPART), BRGY. CALUMANGAN, BAGO CITY**

WHEREAS, in his letter dated October 5, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, authorizing him to sign in the Notices of Award and Purchase Orders (PO) for the following procurement/projects above-mentioned;
