RESOLUTION AMENDING RESOLUTION NO. 01-199, SERIES OF 2001 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE CITY MAYOR TO NEGOTIATE AND SIGN FOR AND IN BEHALF OF THE CITY OF BAGO WITH MS. CELIA KIOK, ET. AL. FOR THE PURCHASE OF LOT IN BARANGAY NAPOLES TO BE UTILIZED AS <u>TWO HECTARES (2 HAS.) FOR RESETTLEMENT SITE AND FOUR</u> HECTARES (4 HAS.) FOR PUBLIC CEMETERY".
