RESOLUTION AMENDING RESOLUTION NO. 01-199, SERIES OF 2001 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE CITY MAYOR TO NEGOTIATE AND SIGN FOR AND IN BEHALF OF THE CITY OF BAGO WITH MS. CELIA KIOK, ET. AL. FOR THE PURCHASE OF LOT IN BARANGAY NAPOLES TO BE UTILIZED AS TWO HECTARES (2 HAS.) FOR RESETTLEMENT SITE AND FOUR HECTARES (4 HAS.) FOR PUBLIC CEMETERY".

WHEREAS, in his letter dated September 27, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, amending Resolution No. 01-199, Series of 2001;

WHEREAS, the utilization of the six hectares area as originally stated in the Resolution be converted to the following:

Four Hectares (4 has.) for Public Cemetery
Two Hectares (2 has.) for Resettlement Site;

WHEREAS, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request.
