RESOLUTION NO. 10-407

RESOLUTION URGING ALL BARANGAY CAPTAINS OF THIS CITY TO MONITOR THE SELLING OF FOOD ITEMS IN THEIR RESPECTIVE BARANGAYS AND TO SEE TO IT THAT VENDORS SELLING MUST HAVE THE NECESSARY SANITARY I.D.'s AND HEALTH CERTIFICATES.

WHEREAS, the Committee on Health convened for a Committee Hearing regarding the reported food poisoning at Barangay Calumangan, this City, of which many individuals were affected;

WHEREAS, in order to prevent food poisoning and unsanitary practices of food vendors and commercial outlets for food in the city, the Barangay Captains are enjoined that necessary sanitary I.D.'s and health certificates are secured before food vendors and food sellers are allowed to sell to the public;

NOW, THEREFORE, upon motion of SP Member Rosario F. Gaudite, unanimously seconded by SP Members present, the Sanggunian

RESOLVES, as it is hereby resolved to urge all Barangay Captains of this city to monitor the selling of food items in their respective barangays and to see to it that vendors selling must have the necessary sanitary I.D.'s and health certificates.
