RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, SCHOOLS DIVISION OF BAGO CITY AND AYALA FOUNDATION, INC. FOR THE IMPLEMENTATION OF PROJECT GILAS (GEARING UP INTERNET LITERACY AND ACCESS FOR STUDENTS) IN THE PUBLIC HIGH SCHOOLS IN THE CITY AND DIVISION OF BAGO.

WHEREAS, in his letter dated November 9, 2010, the Honorable City Mayor is requesting for a Resolution to be passed by this body, authorizing him to sign for and in behalf of the City Government of Bago in a Memorandum of Agreement to be executed by and among the City Government of Bago, Schools Division of Bago City and Ayala Foundation, Inc. for the implementation of Project GILAS (Gearing Up Internet Literacy and Access for Students) in the public high schools in the City and Division of Bago;

WHEREAS, after a thorough deliberation on the matter and finding the request meritorious, it is the consensus of this assembly to grant said request;
