**RESOLUTION AMENDING RESOLUTION NO. 02-183, SERIES OF 2002 TO READ AS FOLLOWS: RESOLUTION APPROVING THE SOCIALIZED HOUSING PROJECT OF THE ENERGY DEVELOPMENT CORPORATION (EDC), LOCATED AT BARANGAY MAILUM, CONTAINING AN AREA OF TEN THOUSAND (10,000) SQUARE METERS, KNOWN AS LOT NO. 2922-A-12, BAGO CADASTRE AND COVERED BY TRANSFER CERTIFICATE TITLE NO. T-23381.**
