**ORDINANCE NO. 20-03**

**AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR WATER EXPENSES OF THE OFFICE OF THE CITY MAYOR THE AMOUNT OF TWENTY FOUR THOUSAND SIX HUNDRED FORTY SEVEN PESOS AND FIFTEEN CENTAVOS (P24,647.15), REPRESENTING THE WATER BILLS OF VARIOUS GOVERNMENT INSTITUTIONS, COVERING THE PERIOD OF NOVEMBER 2019, IN VIEW OF THE CLOSING OF BOOKS OF ACCOUNTS FOR CALENDAR YEAR 2019.**

Be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. The Ordinance authorizing the City Treasurer to charge against the Current Appropriation for Water Expenses of the Office of the City Mayor the amount of Twenty Four Thousand Six Hundred Forty Seven Pesos and Fifteen Centavos (P24,647.15), representing the water bills of various government institutions, covering the period of November 2019, in view of the closing of books of accounts for Calendar Year 2019, is hereby approved.

SECTION 2. This Ordinance shall take effect upon its approval.
