ORLANDO JORGE O. GONZAGA (P5,400.00), DR. FERDINAND RAMON M. MAYOGA (P900.00) AND DR. ELVIS B. GONZALES (P2,500.00), ALL FOR THE MONTH OF DECEMBER 2019, IN VIEW OF THE CLOSING OF BOOKS OF ACCOUNTS FOR CALENDAR YEAR 2019.
