**ORDINANCE NO. 20-07**

**AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR TRAVELLING EXPENSES-LOCAL OF THE BAGO CITY HOSPITAL THE AMOUNT OF ONE THOUSAND ONE HUNDRED EIGHTY PESOS (P1,180.00), REPRESENTING THE REIMBURSEMENT OF DECEMBER 1-31, 2019 TRAVELLING EXPENSES OF RICHARD MACARANG, IN VIEW OF THE CLOSING OF BOOKS OF ACCOUNTS FOR CALENDAR YEAR 2019.**
