AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR OTHER PROFESSIONAL SERVICES OF THE BAGO CITY COLLEGE THE TOTAL AMOUNT OF ONE HUNDRED FOURTEEN THOUSAND NINE HUNDRED PESOS (P114,900.00), REPRESENTING THE HONORARIUM OF PART-TIME INSTRUCTORS FOR THE PERIOD AUGUST 5-DECEMBER 15, 2019, NAMELY: MA. CORAZON ESPARTERO-P16,200.00 DIFFERENTIAL FROM THE RATE OF P250.00/HOUR, REYNA JOY DOTE-P11,400.00 DIFFERENTIAL FROM THE RATE OF P150.00/HOUR, JOSE JEAPEE CANSON-P13,050.00 DIFFERENTIAL FROM THE RATE OF P150.00/HOUR, RHANDALE ALOJADO-P40,500.00, JOY CAMPOS-P33,750.00, IN VIEW OF THE CLOSING OF BOOKS OF ACCOUNTS FOR CALENDAR YEAR 2019.

SECTION 1. The Ordinance authorizing the City Treasurer to charge against Current Appropriation for Other Professional Services of the Bago City College the total amount of One Hundred Fourteen Thousand Nine Hundred Pesos (P114,900.00), representing the honorarium of part-time instructors for the period August 5-December 15, 2019, namely: Ma. Corazon Espartero-P16,200.00 differential from the rate of P250.00/hour, Reyna Joy Dote-P11,400.00 differential from the rate of P150.00/hour, Jose Jeapee Canson-P13,050.00 differential from the rate of P150.00/hour, Rhandale Alojado-P40,500.00, Joy Campos-P33,750.00, is hereby approved.
