**ORDINANCE NO. 20-29**

**AN ORDINANCE AUTHORIZING THE GRANT OF SPECIAL RISK ALLOWANCE AT THE RATE OF FOUR HUNDRED PESOS (P400.00) PER DAY FROM MARCH 30, 2020 TO APRIL 20, 2020 TO REGULAR OFFICIALS AND EMPLOYEES INCLUDING JOB ORDER CASUALS (LABORER) AND CONTRACT OF SERVICES (COS) FRONTLINE PUBLIC HEALTH WORKERS DURING THE PERIOD OF ENHANCED COMMUNITY QUARANTINE RELATIVE TO COVID-19 OUTBREAK, IN COMPLIANCE WITH THE BUDGET CIRCULAR NO. 2020-2, DATED APRIL 7, 2020.**

On motion of SP Member Ruben E. Balboa, unanimously seconded by SP Members present, the Sanggunian

Be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. The Ordinance authorizing the grant of Special Risk Allowance at the rate of Four Hundred Pesos (P400.00) per day from March 30, 2020 to April 20, 2020 to regular officials and employees including job order casuals (laborer) and Contract of Services (COS) Frontline Public Health Workers during the period of Enhanced Community Quarantine relative to COVID-19 Outbreak, in compliance with the Budget Circular No. 2020-2, dated April 7, 2020, is hereby approved.

SECTION 2. This Ordinance shall take effect upon its approval.
