ORDINANCE NO. 20-30

AN AMENDATORY ORDINANCE AMENDING ORDINANCE NO. 20-29 TO READ AS FOLLOWS: "AN ORDINANCE AUTHORIZING THE GRANT OF SPECIAL RISK ALLOWANCE EQUIVALENT TO A MAXIMUM OF 25% OF MONTHLY BASIC SALARY/PAY FROM MARCH 30, 2020 TO APRIL 20, 2020 TO REGULAR OFFICIALS AND EMPLOYEES INCLUDING JOB ORDER CASUALS (LABORER) AND CONTRACT OF SERVICES (COS) FRONTLINE PUBLIC HEALTH WORKERS DURING THE PERIOD OF ENHANCED COMMUNITY QUARANTINE RELATIVE TO COVID-19 OUTBREAK, IN COMPLIANCE WITH THE BUDGET CIRCULAR NO. 2020-2, DATED APRIL 7, 2020".

Be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. The Amendatory Ordinance amending Ordinance No. 20-29 particularly on the "GRANT OF SPECIAL RISK ALLOWANCE AT THE RATE OF FOUR HUNDRED PESOS (P400.00) PER DAY" to "THE GRANT OF SPECIAL RISK ALLOWANCE EQUIVALENT TO A MAXIMUM OF 25% OF MONTHLY BASIC SALARY/PAY" from March 30, 2020 to April 20, 2020 to regular officials and employees including job order casuals (laborer) and Contract of Services (COS) Frontline Public Health Workers during the period of Enhanced Community Quarantine relative to COVID-19 Outbreak, in compliance with the Budget Circular No. 2020-2, dated April 7, 2020, is hereby approved.

SECTION 2. This Amendatory Ordinance shall take effect upon its approval.
