ORDINANCE NO. 20-37

AN ORDINANCE AUTHORIZING THE REVERSION OF FUNDS AS AUTHORIZED UNDER REPUBLIC ACT NO. 11494 (BAYANIHAN TO RECOVER AS ONE ACT) FROM THE SAVINGS OF GENDER AND DEVELOPMENT (GAD) CALENDAR YEAR 2020 IN THE AMOUNT OF THREE MILLION THREE HUNDRED FORTY SIX THOUSAND FIVE HUNDRED SIXTY FIVE PESOS (**P**3,346,565.00) AS FOLLOWS;

- 1. GAD- RESPONSIVE INFORMATION DATABASE SYSTEM (GRIDS) PROJECTS-SEVEN HUNDRED TWENTY ONE THOUSAND ONE HUNDRED THIRTY SIX PESOS (P721,136.00)
- 2. ESTABLISHMENT OF GENDER AND DEVELOPMENT COORDINATING UNIT-TWO HUNDRED EIGHTY ONE THOUSAND FOUR HUNDRED FORTY SIX PESOS (P281,446.00)
- 3. CONSTRUCTION OF GENDER-SEGREGATED COMFORT ROOMS IN PUBLIC SCHOOLS-ONE MILLION TWO HUNDRED FIFTY ONE THOUSAND NINE PESOS (P1,251,009.00)
- 4. UNPROGRAMMED GENDER AND DEVELOPMENT-ONE MILLION NINETY TWO THOUSAND NINE HUNDRED SEVENTY FOUR PESOS (P1,092,974.00)

SAID SAVINGS WILL BE UTILIZED FOR VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES IN THE CONTINUED FIGHT AGAINST COVID-19 AND HELP TO CONTAIN THE EFFECT OF THE SAID PANDEMIC.

On motion of SP Member Ruben E. Balboa, unanimously seconded by SP Members present, the Sanggunian

Be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. The Ordinance authorizing the reversion of funds as authorized under Republic Act No. 11494 (Bayanihan to Recover as One Act) from the savings of Gender and Development (GAD) Calendar Year 2020 for the total amount of THREE MILLION THREE HUNDRED FORTY SIX THOUSAND FIVE HUNDRED SIXTY FIVE PESOS (₱3,346,565.00), is hereby approved.

SECTION 2. This Ordinance shall take effect upon its approval.
