**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE COLLEGE OF EDUCATION, BAGO CITY COLLEGE AND THE SCHOOLS DIVISION OF BAGO CITY FOR THE NEED OF THE STUDENT TEACHERS OF THE COLLEGE OF EDUCATION OF BAGO CITY COLLEGE TO ACQUIRE THE COMPETENCIES SET IN THE NATIONAL COMPETENCY-BASED TEACHERS STANDARDS (NCBTS) AND TO APPLY THEIR LEARNING IN ACTUAL CLASSROOM SITUATIONS IN THE DIFFERENT SCHOOLS WITHIN THE SCHOOLS DIVISION OF BAGO CITY.**

**WHEREAS**, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;


