RESOLUTION NO. 20-021

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE CONTRACT OF LEASE TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF AGRARIAN REFORM (DAR) FOR THE LEASE OF COMMERCIAL BUILDING SITUATED AT THE REGIONAL TRAIL COURT COMPOUND OWNED BY THE CITY GOVERNMENT OF BAGO IN THE AMOUNT OF P4,500.00 PER MONTH WHICH WILL START FROM JANUARY 1, 2020 UNTIL DECEMBER 31, 2020.

WHEREAS, letter dated January 13, 2020 from the Honorable City Mayor, addressed to the Honorable Members, respectfully referred to this Honorable Body for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in the Contract of Lease to be executed by and between the City Government of Bago and the Department of Agrarian Reform (DAR) for the lease of commercial building situated at the Regional Trail Court Compound owned by the City Government of Bago in the amount of P4,500.00 per month which will start from January 1, 2020 until December 31, 2020;

WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;
