WHEREAS, after a thorough deliberation on the matter, the members of this Honorable Body is of the consensus to favorably act on said request;


NOW, THEREFORE, upon motion of SP Member Marina Javellana-Yao, unanimously seconded by SP Members present, the Sanggunian Panlungsod
