JANUARY 30, 2020 PUROK MALIPAYON, BARANGAY NAPOLES

**WHEREAS**, presented in session assembled are requests for the holding of cockfighting activities of the different puroks/barangays of this city;

**WHEREAS**, peace and order must be maintained during said activity by the organizer in coordination with the Bago City Police Station;

**WHEREAS**, existing laws and regulations require that cockfighting activities relative to the celebration of purok, barangay and city local fiesta must be conducted in a duly licensed/designated cockpit of the local government;

**WHEREAS**, the Sangguniang Panlungsod designated Bantayan Park Multi-Purpose Center as the official venue for the conduct of cockfighting activities relative to the purok, barangay and city celebration of their respective local fiesta;
