RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, PHILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION, OVERSEAS WORKERS WELFARE ADMINISTRATION, DEPARTMENT OF LABOR AND EMPLOYMENT-REGION VI AND THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT FOR A JOINT EFFORT IN DISSEMINATING INFORMATION AND ENHANCE EMPOWERMENT AND PROTECTION OF THE PUBLIC AND MIGRANT WORKERS IN THE CITY OF BAGO.
