RESOLUTION APPROVING THE APPLICATION FOR FINAL APPROVAL AND DEVELOPMENT PERMIT OF FOREST LAKE DEVELOPMENT, INC. FOR THEIR PROPOSED MEMORIAL PARK PROJECT SITUATED AT BARANGAY LAG-ASAN, THIS CITY, CONTAINING AN AREA OF EIGHTY FIVE THOUSAND FIVE HUNDRED SEVENTY SEVEN (85,577) SQUARE METERS CONTAINING 15,491 PLOTS.

WHEREAS, in an endorsement letter dated December 2, 2019 from the Honorable City Mayor, addressed to this body, concerning the request of Engr. Ernie Earl D. Baylon, Zoning Officer IV-Designate, for approval, the application for Final Approval and Development Permit of Forest Lake Development, Inc. for their proposed Memorial Park Project situated at Barangay Lag-asan, this City, containing an area of Eighty Five Thousand Five Hundred Seventy Seven (85,577) Square Meters containing 15,491 plots;
