RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE DEED OF DONATION TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF HEALTH FOR THE DONATION OF TWO (2) UNITS AMBULANCE INCLUDING ITS EQUIPMENT FOR THE USE OF THE CITY HEALTH OFFICE, BAGO CITY.

WHEREAS, letter dated February 24, 2020 from the Honorable City Mayor, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for the passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in the Deed of Donation to be executed by and between the City Government of Bago and Department of Health for the donation of two (2) units Ambulance including its equipment for the use of the City Health Office, Bago City;

WHEREAS, said Deed of Donation of two (2) units ambulance will improve the delivery of health service through the upgrading of health facilities and provision of medical equipment in order to make more responsive to the health needs of the population of the City of Bago;
