RESOLUTION CONCURRING THE TRANSFER OF THE CONDUCT OF ACTIVITIES FROM FEBRUARY 11-19, 2020 TO MARCH 8-14, 2020.

WHEREAS, the Department of Health (DOH), Department of the Interior and Local Government (DILG) and the Department of Tourism (DOT) come up with a Joint Statement assuring everyone that it is safe to organize and attend public gatherings, meetings and festivals as long as all precautionary measures identified by the DOH are observed;

WHEREAS, relative to the Joint Statement of the Department of Health (DOH), Department of the Interior and Local Government (DILG) and the Department of Tourism (DOT) on public gatherings, this August assembly is of the consensus to concur with the transfer of the conduct of activities from February 11-19, 2020 to March 8-14, 2020, provided that the City Health Office, Bago City Hospital, DRRM Office, Traffic Management Office and the PNP shall come-up and jointly implement preventive and precautionary measures for these activities;
