RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF AGRICULTURE RFO-VI, WHEREIN THE CITY GOVERNMENT OF BAGO IS ONE OF THE IDENTIFIED QUALIFIED BENEFICIARY OF FARM MECHANIZATION FACILITIES AND EQUIPMENT UNDER THE "ON-FARM MECHANIZATION PROGRAM OF THE DEPARTMENT OF AGRICULTURE RFO-VI.

WHEREAS, letter dated March 3, 2020 from the Acting City Mayor, Honorable Ramon D.
