RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE DEED OF CONDITIONAL DONATION TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF AGRICULTURE RFO-VI, FOR THE DONATION TO THE CITY GOVERNMENT OF BAGO OF GRANULE APPLICATOR AS ONE OF THE IDENTIFIED QUALIFIED BENEFICIARIES OF FARM MECHANIZATION FACILITIES AND EQUIPMENT PROGRAM OF THE DA-RFO VI.

WHEREAS, letter dated March 3, 2020 from the Acting City Mayor, Honorable Ramon D. Torres, addressed to the Honorable Members, Sangguniang Panlungsod, this City, the request for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in the Deed of Conditional Donation to be executed by and between the City Government of Bago and the Department of Agriculture RFO-VI, wherein the DA-RFO VI shall donate to the City Government of Bago GRANULE APPLICATOR as one of the identified qualified beneficiary of Farm Mechanization Facilities and Equipment Program of the DA-RFO VI;
