**A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR TO AMEND THE CONTRACT OF SERVICE ENTERED INTO BY THE CITY GOVERNMENT WITH DR. LESEL S. GANANCIAL EFFECTIVE MARCH 21, 2020 SPECIFICALLY WITH THE FOLLOWING CHANGES:**

1. SHALL RENDER SERVICES AT BAGO CITY HOSPITAL PREFERABLY ON THE FOLLOWING SCHEDULE:  

THURSDAYS	-	10:00PM - 6:00AM
FRIDAYS	-	6:00AM - 2:00PM
SUNDAYS	-	8:00AM - 5:00PM

**CHANGE TO:**

1. SHALL RENDER SERVICES AT BAGO CITY HOSPITAL AND/OR CITY HEALTH OFFICE PREFERABLY ON THE FOLLOWING SCHEDULE:  

MONDAYS	-	8:00AM - 5:00PM
THURSDAYS	-	10:00PM - 6:00AM
FRIDAYS	-	6:00AM - 2:00PM
SATURDAYS	-	8:00AM - 5:00PM
SUNDAYS	-	8:00AM - 5:00PM

2. THAT THE FIRST PARTY SHALL PAY THE SECOND PARTY SEVENTY FIVE THOUSAND PESOS ONLY (P75,000.00) PER MONTH PAYABLE EVERY 15TH AND 30TH/31ST DAY OF EVERY MONTH;

**CHANGE TO:**

2. THAT THE FIRST PARTY SHALL PAY THE SECOND PARTY TWENTY FIVE THOUSAND PESOS ONLY (P25,000.00) PER AN EIGHT-HOUR SHIFT PER MONTH, THUS THE FIRST PARTY SHALL PAY THE SECOND PARTY A TOTAL OF ONE HUNDRED TWENTY FIVE THOUSAND PESOS ONLY (P125,000.00) FOR A FIVE (5) EIGHT-HOUR SHIFT PER MONTH PAYABLE EVERY 15TH AND 30TH/31ST DAY OF EVERY MONTH.

**WHEREAS**, letter dated March 17, 2020 from the Honorable City Mayor, addressed to this Honorable Body, the request for the passage of a Resolution granting authority to the Honorable City Mayor to amend the Contract of Service entered into by the City Government with Dr. Lesel S. Ganancial effective March 21, 2020 with the above-mentioned changes;

**WHEREAS**, this request is certified URGENT, due to the treat of Corona Virus Disease 2019 (COVID19);

**WHEREAS**, after a thorough deliberation on the matter, is of the consensus to grant said request;

**NOW, THEREFORE**, upon motion of SP Member Andrew Martin Y. Torres, unanimously seconded by SP Members present, the Sangguniang Panlungsod
