WHEREAS, in a letter dated March 10, 2020 from the Honorable City Mayor and addressed to this Honorable body, the request for the passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City Government of Bago in Contracts of Services to be executed by and between the above-stated persons and the City Government of Bago;
