ORDINANCE NO.19-10

AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR OTHER MAINTENANCE AND OPERATING EXPENSES OF THE OFFICE OF THE CITY MAYOR THE AMOUNT OF FORTY FIVE THOUSAND PESOS (P45,000.00), REPRESENTING THE MEALS SERVE TO THE BUREAU OF FIRE PROTECTION PERSONNEL FOR OPLAN PAALALA AND OPLAN IWAS PAPUTOK CAMPAIGN FROM DECEMBER 24, 2018 TO DECEMBER 31, 2018, IN VIEW OF THE CLOSING OF BOOK OF ACCOUNTS FOR CALENDAR YEAR 2018.

SECTION 1. The Ordinance authorizing the City Treasurer to charge against Current Appropriation for Other Maintenance and Operating Expenses of the Office of the City Mayor the amount of Forty Five Thousand Pesos (P45,000.00), representing the meals serve to the Bureau of Fire Protection Personnel for Oplan Paalala and Oplan Iwas Paputok Campaign from December 24, 2018 to December 31, 2018, in view of the closing of book of accounts for Calendar Year 2018, is hereby approved.


