ORDINANCE NO.19-14

AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR SALARIES AND WAGES-REGULAR AND YEAR END BONUS OF THE CITY BUDGET AND MANAGEMENT OFFICE THE AMOUNT OF FOUR THOUSAND NINETY EIGHT PESOS (P4,098.00) AND TWO THOUSAND FORTY NINE PESOS (P2,049.00), RESPECTIVELY, REPRESENTING THE OCTOBER 2018 TO NOVEMBER 2018 SALARY AND YEAR END BONUS DIFFERENTIAL OF MRS. MYLA M. ESPENDE AS COMPUTER OPERATOR I OF THE SAID OFFICE, IN VIEW OF THE CLOSING OF BOOK OF ACCOUNTS FOR CALENDAR YEAR 2018.

SECTION 1. The Ordinance authorizing the City Treasurer to charge against Current Appropriation for Salaries and Wages-Regular and Year End Bonus of the City Budget and Management Office the amount of Four Thousand Ninety Eight Pesos (P4,098.00) and Two Thousand Forty Nine Pesos (P2,049.00), respectively, representing the October 2018 to November 2018 Salary and Year End Bonus Differential of Mrs. Myla M. Espende as Computer Operator I of the said office, in view of the closing of book of accounts for Calendar Year 2018, is hereby approved.

SECTION 2. This Ordinance shall take effect upon its approval.
