ORDINANCE NO.19-15

AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION THE ELECTRICITY EXPENSES OF THE OFFICE OF THE CITY ENGINEER AMOUNTING TO THIRTY NINE THOUSAND SIX HUNDRED SIXTY EIGHT PESOS AND THIRTY ONE CENTAVOS (P39,668.31) REPRESENTING THE ELECTRICITY BILLS OF BARANGAY SAGASA STREETLIGHTS COVERING THE PERIOD FROM JULY 2018 TO DECEMBER 2018, IN VIEW OF THE CLOSING OF BOOK OF ACCOUNTS FOR CALENDAR YEAR 2018.

The Ordinance authorizing the City Treasurer to charge against Current Appropriation the Electricity Expenses of the Office of the City Engineer amounting to Thirty Nine Thousand Six Hundred Sixty Eight Pesos and Thirty One Centavos (P39,668.31) representing the Electricity Bills of Barangay Sagasa Streetlights covering the period from July 2018 to December 2018, in view of the closing of book of accounts for Calendar Year 2018, is hereby approved.

SECTION 2. This Ordinance shall take effect upon its approval.
