RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE OF FOREST LAKE DEVELOPMENT, INC. FOR THEIR PROPOSED MEMORIAL PARK PROJECT SITUATED AT BARANGAY LAG-ASAN, THIS CITY, CONTAINING A TOTAL AREA OF EIGHTY FIVE THOUSAND FIVE HUNDRED SEVENTY SEVEN (85,577) SQUARE METERS.

WHEREAS, in an endorsement letter dated November 26, 2018 from the Honorable City Mayor, addressed to this body, concerning the request of Engr. Ernie Earl D. Baylon, Zoning Officer IV-Designate, for approval, the application for Preliminary Approval and Locational Clearance of Forest Lake Development, Inc. for their Proposed Memorial Park Project situated at Barangay Lag-asan, this City, containing a total area of Eighty Five Thousand Five Hundred Seventy Seven (85,577) Square Meters; and
